#### **1. COMPANY PROFILE:**

UKMRC has been setup by Government of Uttarakhand as a special Purpose Vehicle for implementation and operation of Rail Based Mass Rapid Transit System (Metro) in selected cities of Uttarakhand with Headquarters at Dehradun.

#### 2.JOB DESCRIPTION AND RESPONSIBILITIES:

The Candidate shall be responsible for the overall functions of finance and Accounts, where work shall be related to the fields such as taxation, audit and other related matters of the Corporation. The incumbent should have the knowledge of corporate accounting, financial management, taxation- direct/indirect, treasury management, corporate governance, tender evaluation, vetting of contracts/ offers/estimates etc.

# 3. ELIGIBILITY CRITERIA:

- a. The applicant should be working in Finance department of any Metro Rail Corporation /Railways/other PSUs.
- b. Applicants who are a Member of the Institute of Chartered Accountants of India OR Member of the Institute of Cost Accountant of India OR MBA with specialization in Finance from a reputed Institute, will have added advantage.
- I. AGE (As on 31-03-2019):- Maximum- 58 years.

# II. PAY SCALE:

The applicant should be a working officer in any of the following pay scales:-

- I. CDA Scale:
- a) SAG Level (CDA Pay Scale- Rs. 37400-67000; Grade pay Rs. 10000/- (Level-14 in 7th CPC)

OR

b) Should be working in Selection Grade (GP 8900/-) with minimum service of two years in this scale, as on 31-03-2019.

- II. IDA Pay Scale:-
- a) Rs. 51300-73000 (Revised Pay Scale 120000-280000)

OR

b) Rs. 43200-66000 (revised pay scale Rs. 100000-260000), with minimum service of two years in this scale, as on 31-03-2019.

## **4.PRIORITY IN SELECTION**

## **5. DURATION OF APPOINTMENT:**
