- F. Appointment will be initially for the period of one year and will be extendable further on yearly basis up to maximum of 03 years on the basis of satisfactory work & conduct report from concerned HOD and a written request by the Official.
- G. <u>Appointment will be subject Medical fitness and verification of certificate of educational qualification</u> /age /caste /DMC registration and Internship completion certificate etc.
