- **1.0 Place of Posting:** Bangalore (Karnataka), Kochi (Kerala), Goa, Arakonnam (Tamil Nadu), Vizag (Andhra Pradesh), Mumbai (Maharashtra), Port Blair (Andaman & Nicobar Island).
- **Qualification:** First class for General and OBC Candidates and Pass Class for SC/ST / PWD candidates in BE / B.Tech/ B.SC Engineering/ AMIE from a recognized University/ Institution. Only the following disciplines are allowed
